

Greek National Supplement

1. Host of the National Rounds

University of Athens, Faculty of Law

2. Date of the National Rounds

26 February 2011

3. Costs

The costs of the tournament shall be borne jointly by the participating Teams. The costs related specifically to hosting the tournament will be borne by the University of Athens Law Faculty, which includes providing a venue for the rounds and other events and providing access to library and computer facilities.

4. National Rounds Staff

The National Administrators may appoint any individual(s) of their choosing as staff (i.e. bailiffs, etc.).

These individuals shall have no direct affiliation with any Jessup team. An affiliated individual means a member, advisor, or practice judge to a Jessup team. The National Administrators shall take all necessary measures to maintain a separation between the administration of the tournament and participating teams.

5. Memorials

- a. The ILSA Executive Office will handle the grading of memorials and assessment of memorial penalties. The ILSA Executive Office shall deliver such scores and penalty assessments to the National Administrators the latest 48 hours before the commencement of the tournament.
- b. The National Administrators shall email opponent memorials to each team by 11 February 2010.
- c. Each Team shall mail three hard copies of the Applicant and the Respondent Memorial to the National Administrators by a date to be determined by the National Administrator, which shall be no earlier than 11 February 2010. Hard copies must be identical to the ones submitted electronically. Differences in formatting and pagination due to printing in A4 size are acceptable.

6. Oral Rounds

- a. The pairing shall be as follows:
 - i. Round A: 1A v. 2R

- ii. Round B: 2A v. 1R
- b. The National Administrators shall draw lots to determine which teams will correspond to teams 1 and 2 in the above schedule.
- c. After seeking input from teams, the National Administrators shall determine at which time the above matches will take place.

7. List of Judges

- a. The National Administrators shall prepare a list of persons eligible to judge, pursuant to the eligibility criteria of this Supplement and the Official Rules, and will submit it to the participating Teams.
- b. The Teams may add persons to the list and may request the removal of potential judges from the list.
- c. The National Administrators shall set the date on which the list shall be considered final.
- d. When the list is finalised, no addition or removal can be proposed. The National Administrators may only remove a person from the list, if such person does not fulfill the eligibility criteria.

8. Composition of the Bench

- a. The National Administrators shall be responsible to select the composition of the Bench for each round, from the list of potential Judges, provided that no Judgee shall allowed to judge more than one round.
- b. The Teams shall have no standing to request the change of the bench composition, unless any the Official Rules would be violated if the round were to proceed with the composition provided.

9. Penalties and Appeals

- a. The National Administrators shall have authority to penalize teams during the Oral Rounds under the Official Rules.
- b. Teams may appeal any decision or penalty of the National Administrators to the ILSA Executive Office. Such appeals shall be in writing and sent to the ILSA Executive Director without delay.
