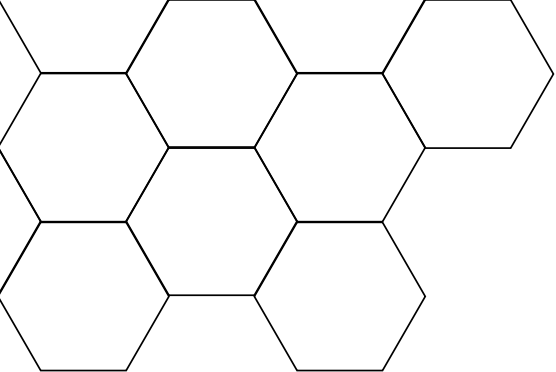

Why Sponsor Us?

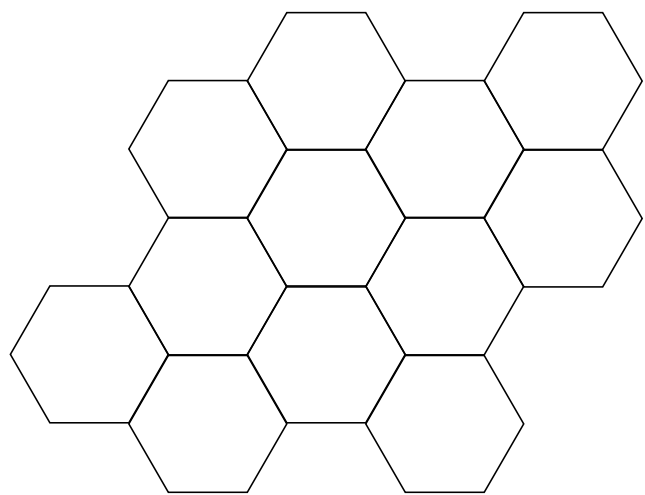
