

**INDONESIAN NATIONAL ROUND RULES SUPPLEMENT  
OF THE 2026 PHILIP C. JESSUP INTERNATIONAL  
LAW MOOT COURT COMPETITION**

The Indonesian National Rules Supplement to the Official Rules of the 2026 Philip C. Jessup International Law Moot Court Competition. (**“Indonesian National Rules Supplement”**) has been promulgated by the Indonesian National Administrator (**“Administrator”**) with the approval of the Executive Director of the International Law Students Association.

The present Indonesian National Rules Supplement is intended to facilitate the conduct of the 2026 Indonesian National Round of Philip C. Jessup International Law Moot Court Competition (**“National Rounds”**). The Indonesian National Rules Supplement clarifies and complements the Official Rules for the 2026 Philip C. Jessup International Law Moot Court Competition (**“Official Rules”**). The Administrator may set out supplemental guidelines pertaining to technical issues of the 2026 Indonesian National Round (**“Technical Guidelines”**).

The Indonesian National Rules Supplement shall not preclude the Administrator from adopting any additional measure prior to, during, and following the 2026 Indonesian National Round pursuant to Rule 1.8 of the Official Rules.

**Rule 1.0: Organization of the Competition and Number of Representatives from Indonesia**

- 1.1 The National Rounds are hosted by the Indonesian Society of International Law (**“INASIL”**) and co-hosted by Universitas Gadjah Mada.
- 1.2 The National Rounds are administered by an Administrator appointed by INASIL and approved by the International Law Student Association:

- 1.3 The number of the Representatives from Indonesia, determined in accordance with Rule 1.2(b) of the Official Rules, is three teams.
- 1.4 The Indonesian National Representatives to the International Rounds shall be the Champion, Runner Up, and Second Runner Up.
- 1.5 The Second Runner Up position shall be determined based on the results of the Third-Place Playoff Round, which will be contested by the Semifinalists who did not advance to the Final Round.

## **Rule 2.0: Eligibility, Selection, and Outside Participation**

- 2.1 Participation in the National Rounds is limited to students who are enrolled in an undergraduate (S1) program at an accredited university at the time of registration
- 2.2 The following individuals are not permitted to advise a Team or to serve as a judge in practice Moots:
  - a) any Team Member from other Teams;
  - b) any individual who intends to serve as a judge in the National Rounds; and
  - c) any individual who intends to serve on a committee in the National Rounds or INASIL.
- 2.3 With regards to Rule 2.17 of the Official Rules, posting pictures of the Team or the Team Members on social media or publicly available websites does not constitute a violation of anonymity under the Official Rules nor the Indonesian National Rules Supplement.

## **Rule 3.0: Memorials**

- 3.1 In accordance with Rule 5.1(b) of the Official Rules, all Teams shall submit their Applicant and Respondent Memorials to the Executive Office via the team homepage no later than 12 January of 2026 at 17:00 (5:00 p.m.) Central Standard Time (CST) (GMT – 6).
- 3.2 Teams are not required to submit their Applicant and Respondent Memorials to the Administrator of the Indonesian National Rounds.
- 3.3 All teams shall provide 4 (four) hard copies of each of their Applicant and Respondent Memorials to the Competition Division of the Administrator one day before the commencement of the National Rounds.
- 3.4 In the event that Teams do not provide hard copies of their memorials as required in Rule 3.3 of the Indonesian National Rules Supplement, they will not be able to complete the re-registration process for the National Rounds.
- 3.5 During Elimination Rounds:
  - a) Teams will receive a maximum of 2 (two) hard copies and a soft copy of the opposing Team's Applicant or Respondent Memorial.
  - b) The bench of judges will receive a hard copy of the relevant Applicant and Respondent Memorials.
  - c) The bench of judges may ask for an additional hard copy of the relevant Applicant and/or Respondent Memorial if necessary to assess the Team's oral presentation.
  - d) Teams and judges shall keep the given hard copies of the Memorial clean and intact. The hard

copies of the Memorials will be used for the entirety of the National Rounds and must be returned to the committee at the end of each Match of the Elimination Rounds.

- e) The hard copies will be used for the entirety of the National Rounds and must be returned to the committee at the end of each Match of the National Rounds.

#### **Rule 4.0: Procedure of The National Round**

**4.1** The National Rounds shall be conducted in Universitas Gadjah Mada.

#### **4.2 Preliminary Rounds**

- 4.2.1 Prior to the commencement of the National Rounds, the Administrator will hold a technical meeting for the Teams, judges, and observers. Teams are required to send at least one Team Member to the technical meeting.
- 4.2.2 Teams shall arrive at the venue at least 60 (sixty) minutes before the commencement of the Preliminary Rounds. A Team that fails to appear within ten (10) minutes of the commencement of the National Rounds shall forfeit its scheduled match.
- 4.2.3 Each team shall compete four (4) times in the Preliminary Rounds, twice as Applicant and twice as Respondent.
- 4.2.4 The Administrator shall determine the pairings through a random draw. The pairings will be distributed to Teams via the Team Portal Page prior to the Preliminary Rounds. The Administrator may modify the pairings to account for absent Teams or other contingencies.

#### **4.3 Quarterfinals Rounds**

- 4.3.1 The Quarterfinal Rounds shall be conducted among the eight (8) highest-ranking Teams from the Preliminary Rounds. The purpose of the Quarterfinal Rounds is to determine the four (4) Teams that shall advance to the Semi-final Rounds.
- 4.3.2 The pairings for the Quarterfinal Rounds shall be determined through power-seeding in accordance with Section 8.4 of the Official Rules. The higher-ranked Team in each pairing has the right to select the side on which they will argue (Applicant or Respondent).
- 4.3.3 To maintain the orderly conduct of the Rounds, Teams are required to arrive at the venue at least 45 (forty-five) minutes before the scheduled start of their match. A Team that fails to appear within 10 (ten) minutes after its designated starting time shall be declared as forfeiting the Round by the Administrator.
- 4.3.4 Following confirmation of the pairings, the Memorials of the opposing Teams will be distributed via the Team Portal Page. In circumstances where Teams must be newly paired due to contingencies, the revised Memorials shall be provided as soon as reasonably possible, and in any event no later than 15 (fifteen) minutes before the start of the newly paired Moot,

pursuant to Section 8.3 of the Official Rules.

#### **4.4 Semi-final Rounds**

- 4.4.1 The Semi-final Rounds shall be conducted among the four (4) Teams that prevailed in the Quarterfinal Rounds. These Rounds shall determine the two (2) Teams that will advance to the Championship Round.
- 4.4.2 The pairings for the Semi-final Rounds shall be determined through power-seeding in accordance with Section 8.5(a) of the Official Rules.

#### **4.5 Judges**

- 4.5.1 Judges of The National Round shall be selected in accordance with the spirit of Section 5.0 of the Official Rules. Judges are required to remain impartial and must disclose any affiliation with a participating university, coach, or Team member, including but not limited to being an alumnus of the Team's institution.
- 4.5.2 The Administrator shall use best endeavors to avoid assigning a Judge to an Oral Round in which the Judge has an affiliation. If this cannot be avoided, the National Administrator shall ensure that no more than one (1) affiliated Judge is placed on the panel and the affiliated Judge does not serve as President of that panel.

#### **Rule 5.0: Complaints About the Conduct or Result of a Match and the Conduct of the Indonesian National Rounds**

- 5.1 In the event that teams intend to submit a claim regarding the conduct of the National Rounds they shall do so according to the stipulations under Rule 11.11 of the Official Rules.
- 5.2 Complaints of the manner stipulated under Rule 5.1 of the Indonesian National Rules Supplement shall be reported to the Administrator as soon as the violation is known to the team, at the latest 15 minutes after the Match is completed. If the Team fails to report such violation within the specified time period, it is considered that the team has waived the rights to submit the claim.
- 5.3 All complaints and appeals made during the duration of the National Rounds must be informed to the Administrator.

#### **Rule 6.0: Technical Guidelines**

- 6.1 The Administrator will complement the Indonesian National Rules Supplement with Technical Guidelines containing technical information and direction for the conduct of the 2026 Indonesian National Round.
- 6.2 In case of non-compliance of the Technical Guidelines, Teams, observers, spectators, and committees will not be admitted and/or be able to complete re- registration for the In-Person

Moot.

**Rule 7.0: *Ex Parte* or Reschedule Proceedings**

- 7.1 When needed, the Administrator will use their best efforts to administer *ex parte* or reschedule Moots based on the available circumstances.
- 7.2 The Administrator will adopt the *ex parte* or reschedule procedure as provided under the Official Rules and may vary such procedures in the best interest of the 2026 Indonesian National Round.
- 7.3 In the case of In-Person Moot, the Administrator shall not conduct *ex parte* or reschedule Moots during the In-Person Moot, except under *force majeure* circumstances as follows:
  - a) Riot, rebellion, terrorism, pandemic, warfare, or blockade;
  - b) Natural disasters, including typhoons, floods, fires, or earthquakes;
  - c) Government policy changes directly affect the commencement of the In-Person Moot.

**Rule 8.0: 2026 Indonesian National Round Awards**

- 8.1 The awards that will be presented to the participating Teams of the 2026 Indonesian National Round are as follows:
  - a) Champion Team;
  - b) Second Place Team;
  - c) Third Place Team;
  - d) Best Combined Memorials;
  - e) Second Best Combined Memorials;
  - f) Best Applicant Memorial;
  - g) Second Best Applicant Memorial;
  - h) Best Respondent Memorial;
  - i) Second Best Respondent Memorial;
  - j) Best Oralist;
  - k) Second Best Oralist;
  - l) Third Best Oralist; and
  - m) Spirit of Jessup Award

8.2 The Administrator may create or reduce the awards as they see fit.

**Rule 9.0: Copyright and Documentation**

- 9.1 INASIL and the Administrator have the right to take any documentation in the form of photographs, video footage, Match broadcasting on the internet, or any other kind of documentation for publicity purposes during the 2026 Indonesian National Round.
- 9.2 INASIL and the Administrator have the copyright of all documentation taken and made by the committee during the 2026 Indonesian National Round
- 9.3 In accordance with Rule 6.15 and 7.22 of the Official Rules, Teams, observers, and/or spectators are prohibited to take any documentation of any Match
- 9.4 By registering and/or participating in the 2026 Indonesian National Round, all Participants of the 2026 Indonesian National Round are deemed to have consented to Rule 10 of the Indonesian National Rules Supplement.
